Whereas, the property hereinafter described was conveyed to William H. Beattie and A. M. Rickman, as Trustees for A. Eliza Marshall, et al., the deed being recorded in the R. M. C. Office for Greenville County, S. C., in Vol. 112, page 590, in which deed the Grantors created an Executive Committee composed of S. M. Beattie, C. C. Withington and Alfred W. Marshall, to manage, control and authorize the sale of said property; and

Whereas, the said deed further provided that the Trustees should hold the legal title to said property and should convey same upon request of the Executive Committee, or a majority of said Committee; and

Whereas, the said Executive Committee, or a majority thereof, requested that this conveyance be made to Edward C. Karolyi

NOW THEREFORE

KNOW ALL MEN BY THESE PRESENTS, That We, William H. Beattie and A. M. Rickman, as Trustees for A. Eliza Marshall et al

in the State aforesaid in consideration of the sum of Seven Hundred Thirty (\$730.00)

DOLLARS

to us Edward C. Karolyi in hand paid, at and before the sealing of these presents by

in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release, unto the said Edward C. Karolyi, his heirs and assigns, forever.

All that certain piece, parcel or lot of land situate, lying and being on the North side of Central Avenue, in the City of Greenville, County of Greenville, State of South Carolina, being shown as Lot #8 on Plat of Marshall Estates, made by Dalton & Neves, Engineers, May 1932, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book "H", Page 253, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the North side of Central Avenue at joint front corner of Lots 7 and 8 and running thence with the line of Lot 7, N. 11-11 W. 95.6 feet to an iron pin; thence N. 82-09 E. 76.8 feet to an iron pin at corner of Lot 9; thence with the line of Lot 9, S. 3-05 W. 103.3 feet to an iron pin; on the North side of Central Avenue; thence with the North side of Central Avenue, S. 88-59 W. 52 feet to the beginning corner.

The property described herein is conveyed subject to the following building restrictions:

1. No residence shall be erected upon said lot nearer than 20 feet to the street on which the residence shall face and no garage shall be erected thereon nearer than 20 feet to any street line.
2. No residence shall be erected on said lot costing less than \$2000.00.
3. This lot shall be used for residential purposes only and shall not be subdivided so as to face any direction other than as shown on the plat thereof referred to herein.
4. This lot shall never be sold, rented or otherwise disposed of to persons of African descent.

We, the undersigned, a majority of the Executive Committee for A. Eliza Marshall et al, hereby request, authorize and direct William H. Beattie and A. M. Rickman, as Trustees, for A. Eliza Marshall, et al. to convey to Edward C. Karolyi the property described herein.
