KNOW ALL MEN BY THESE PRESENTS, That Central Realty Corporation

a corporation chartered under the laws of the State of South Carolina and having its principal place of business at Greenville in the State of South Carolina for and in consideration of the sum of Forty-five Hundred & no/100 DOLLARS, (\$4,500.00)

to it in hand duly paid at and before the sealing and delivery of these presents by the grantee hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Frederick L. Wittkamp, his

heirs and assigns:

All that certain piece, parcel, or lot of land situate, lying and being on the South side of Piney Road, County of Greenville, State of South Carolina, being known and designated as Lot No. 3 of a section known as Shrinewood, according to a plat of Central Realty Corporation property, made by W. J. Riddle July 1946, recorded in the R. M. C. Office for said Greenville County in Plat Book B, page 86, and having according to said plat the following metes and bounds, to-wit:

Beginning at a stake on the South side of said Piney Road which is the joint corner of lots Nos. 2 and 3 according to said plat, and running thence with the said Piney Road, S. 73-0 W. 70 feet to a stake at the joint corner of lots Nos. 3 and 4; thence along the joint line of said lots Nos. 3 and 4, S. 17-0 E. 231 feet to a stake at the joint rear corner of lots Nos. 3 and 4; thence N. 73-0 E. 70 feet to a stake at the joint rear corner of lots Nos. 2 and 3; thence along the joint line of said lots Nos. 2 and 3, N. 17-0 W. 231 feet to the point of beginning, stake at the joint corner of lots Nos. 2 and 3 on the South side of Piney Road.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the grantee hereinafter named, and his heirs and assigns forever.
