in consideration of the sum of Eighteen Hundred, Twenty-Five and 95/100 in the State aforesaid

and assumption of mortgage set out below;

in the State aforesaid, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release, unto the said W. W. Jordan, his heirs and assigns forever:-

All that piece, parcel or lot of land in Gantt Township, Greenville County, State of South Carolina.

and being east of the Augusta Road, five miles from Greenville County Courthouse, being shown as the rear part of Lot No. 1 on plat of property of Julia D. Charles made by W. J. Riddle, Surveyor, September 16, 1936, containing 25.20 acres, more or less, and having, according to said plat, the following metes and bounds, to-wit:-

BEGINNING at an iron pin at the southeast corner of Lot No. 2 on said plat, said pin being approximately 1101.6 feet northeast from the joint front corner of Lots Nos. 1 and 2 on Augusta Road, and running thence across road leading from the tract of land hereind escribed to the Augusta Road, S. 26-30 E. 40 feet, more or less, to an iron pin on southeast side of said road in line of property of H. J. Winn; thence with said Winn property, N.50-00 W. 758 feet, more or less, to iron pin at corner of property of Greater Greenville Sewer District Commission to a stone; thence with line of said Greater Greenville Sewer District Commission property, N. 30-30 W. 1340 feet to a point on the north bank of Brushy Creek; thence up Brushy Creek following the center thereof as the line, N. 78-00 W. 218 feet to a point; thence continuing with the center of Brushy Creek, N. 72-10 W. 284 feet to a point; thence continuing with the center of Brushy Creek, N. 77-20 W. 150 feet to a point; thence leaving Brushy Creek and running S. 52-15 W. 151 feet, more or less, to an iron pin at the northeast corner of Lot No. 9 on plat referred to above; thence along the rear of Lots 9, 8, 7, 6, 5, 4, 3, 2, S. 26-30 E. 1832.5 feet to the beginning corner.

Also, together with an easement and right-of-way for the purpose of ingress and egress to and from the above described property in and over that road leading across property of Lucille B. Knox to Augusta Road and the same shall be at all times kept open for the use of the grantee herein, his servants, agents, employees, heirs and assigns.

The grantee herein expressly assume and agrees to pay a certain note and mortgage in the original sum of \$1500.00 executed by T. R. Davis to Chas. E. Robinson, as Trustee, recorded in Vol. 333, page 273, on which there is a balance due as of December 19th, 1946 including fire insurance premium advanced, amounting to \$1074.05.
