All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville and in Chick Springs Township 8-AC, being a portion of the property of the T. P. Raines Estate and being more particularly described as follows:

Beginning at an iron pin at the corner of other property of the grantor at a point 130 feet west of the northwest corner of Raines Avenue and C. Street, and running thence along the line of grantor's property in a northwesterly direction, 190 feet to an iron pin; thence in a southwesterly direction, 60 feet to an iron pin at the corner of lot now or formerly belonging to Mrs. Nations; thence along the line of her property in a southeasterly direction, 190 feet to an iron pin on C street; thence along the line of C.
