KNOW ALL MEN BY THESE PRESENTS, That Central Realty Corporation,

a corporation chartered under the laws of the State of South Carolina and having its principal place of business at Greenville in the State of South Carolina for and in consideration of the sum of Forty-seven Hundred & no/100 (\$4,700.00) DOLLARS,

to it in hand duly paid at and before the sealing and delivery of these presents by the grantee hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Raymond A. Chastain, his heirs and assigns:

All that piece, parcel or lot of land situate, lying and being on the southern side of Durham Street, near the City of Greenville, County of Greenville, State of South Carolina, known and designated as Lot No. 11 on a plat of property of Central Realty Corporation, made by Pickell & Pickell, June 2, 1946, recorded in the R. M. C. Office for Greenville County in Plat Book B, page 199, and having according to said plat the following metes and bounds, to-wit:

Beginning at a stake at the southeastern intersection of Durham Street, and Merritt Street, and running thence along the said Merritt Street, S. 18-03 E. 150 feet to a stake on said Merritt Street which is the rear corner of lot 11; thence N. 69-30 E. 80 feet to a stake at the rear corner of lot No. 12; thence along the line of said lot, N. 22-00 W. 150 feet to a stake on Durham Street, corner of said lot No. 12; thence along the said Durham Street, S. 69-30 W. 70 feet to the point of beginning.
