AGREEMENT

WHEREAS, Paul V. Stiller is the owner of lot No. 12 as shown on plat of Carolina Court, recorded in Plat Book "F", page 96, said lot being adjacent to the home of Paul V. Stiller which is located upon lot No. 13 and,

WHEREAS, Freda Mae Davis, a sister-in-law of Paul V. Stiller is desirous of acquiring a home for herself and her mother, Mrs. Rosa Davis, and,

WHEREAS, it is mutually desirable that said home be located near or adjacent to the home of Mr. and Mrs. Paul V. Stiller,

NOW, THEREFORE, This agreement made and entered into this 29th day of December, 1945 by and between Paul V. Stiller, hereinafter referred to as party of the first part, and Freda Mae Davis, hereinafter referred to as party of the second part;

That the party of the first part has this day executed and delivered a deed conveying lot No. 12 on plat recorded in Plat Book "F", page 96, to Freda Mae Davis, conveying said lot to the grantee in fee simple with the full right to mortgage the same as is evidenced by a deed of even date herewith, in which the consideration is expressed as One(\$1.00) Dollars.
- 2. The party of the second part, in consideration of the conveyance by the party of the first part, agrees as follows:
- (a) To construct a house upon said lot at her own expense, said house to be used as a home by the said Freda Mae Davis and her mother, Mrs. Rosa Davis, or the survivors of them.
- (b) The party of the second part agrees to execute a Will devising the property hereinabove referred to, that is lot No. 12 and the house to be erected thereon, after her death and that of her mother, Mrs. Rosa Davis, to the children of Paul V. Stiller in equal shares, share and share alike.

IT IS MUTUALLY UNDERSTOOD AND AGREED that the conveyance first above referred to is the true consideration of this contract as well as the Will to be executed by Freda Mae Davis, and that this Agreement shall be binding upon the parties hereto, their heirs and assigns.
