BEGINNING at a stone and running thence S. 1 1/4 E. 12.70 to a stake on Mrs. Bailey's line; thence N. 43 E. 29.64 to a post Oak; thence N. 55 E. 3.70 to a stake; thence N. 32 W. 5.95 to a stone NM on B. F. Neves' line; thence S. 57-3/4 W. 10.60 to a stake on Meadow Fork Creek; thence up the meanders of said creek 10.80 to a branch; thence up branch as a line 5.40 to a stake in branch on old line; thence S. 5 E. 6.50 to the beginning corner and containing 31.50 acres, more or less, and being the same property conveyed to Hosea Bishop by M. P. Trammell.
