BEGINNING at an iron pin on Fairview Avenue, 508 feet from the southeast intersection of Laurens Road and Fairview Avenue, corner of lot 11, and running thence along Fairview Avenue 50 feet, S. 31-47 W. to iron pin, corner of lot 13; thence along line of lot 13, S. 58-40 E. 132 feet to iron pin, joint corner of lots 12, 13, 24 and 25; thence along rear line of lot 25 N. 31-20 E. 50 feet to iron pin, joint corner of lots 11, 12, 25 and 26; thence along line of lot 11, N. 58-40 W. 131.7 feet to beginning corner.
