Allen, his heirs and assigns forever: all that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina.

on the south side of Cobb Street and being known and designated as Lot No. 24 of a subdivision known as "New Hope", as shown on plat thereof recorded in the R. M. C. office for Greenville County in Plat Book A, at page 307, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the south side of Cobb Street at the corner of Lot No. 23, which point is 170 feet west of the southwest corner of the intersection of Cobb street and Miller street, and running thence along the line of said Lot No. 23, S. 10 3/4 W. 150 feet to an iron pin at the rear corner of said lot; thence N. 79-15 W. 60 feet to an iron pin at the rear corner of Lot No. 25; thence along the line of said Lot No. 25, N. 10 3/4 E. 150 feet to an iron pin at the corner of Lot No. 25 on the south side of Cobb Street; thence along the line of said Cobb Street, S. 79 -15 E. 60 feet to the beginning corner.
