*Know all Men by these Presents, That* We, Jimmy Roper, N. E. Richardson and Fred Adams, as Trustees of the Church of God located at West Greenville, South Carolina,

in the State aforesaid,

in consideration of the sum of One and No/100 (\$1.00) and the recitals set out below Dollars

to us paid by N. E. Richardson, Fred Adams and Frank Jones, State Trustees of the Church of God, National Headquarters, 303 Bible Place, Cleveland, Tennessee,

in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said N. E. Richardson, Fred Adams and Frank Jones, State Trustees of the Church of God, National Headquarters, 303 Bible Place, Cleveland, Tennessee, and their successors in office,

All that piece, parcel or lot of land in Greenville Township, Greenville County, State

of South Carolina, located on the Northern side of Pendleton Road, being known and designated as Lots Nos. 2 and 3 of Brandon Annex on plat recorded in the R. M. C. Office for Greenville County in Plat Book "C" at Page 173, and being more particularly described by metes and bounds, as follows:

BEGINNING at an iron pin on the Northern side of Pendleton Road at the joint corner of Lots Nos. 3 and 4, and running thence with the line of Lot No. 4, N. 23-30 E. 130 feet to an iron pin; thence S. 71 E. 100 feet to an iron pin, corner of Lot No. 1; thence with the line of Lot No. 1, S. 23-30 W. 130 feet to an iron pin on Pendleton Road; thence with the Northern side of Pendleton Road in a Westerly direction, 100 feet to the beginning corner; said premises being the same conveyed to the grantors by E. Blanche Creech by deed recorded in Volume 275 at Page 88.

ALSO, all that other lot of land known and designated as Lot No. 13 of Brandon Annex on plat recorded in the R. M. C. Office for Greenville County in Plat Book "C" at Page 173, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a stake at the joint corner of Lots Nos. 12 and 13 on Lindall Avenue, and running thence with said Lindall Avenue, S. 77 E. 47 feet to a stake; thence S. 9-30 E. 182 feet, 7 inches to a stake; thence N. 71 W. 68 feet, 8 inches to a stake; thence N. 9-30 W. 165 feet, 6 inches to the beginning corner; being the same premises conveyed to The Church of God by Mrs. Alma Liddell by deed recorded in Volume 197 at Page 21.

This deed is executed pursuant to authority contained in the following resolution which was unanimously adopted at a meeting of the congregation held February 9, 1947:
