All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, in Ward 6 of the City of Greenville, being located on the North side by Tindal Avenue, on the East by Capers Street, or the South by Crescent Avenue and on the West by property now or formerly of James J. Prince and being known and designated as the corner lot, in the town of Greenville, all of Lot D, the greater portion of Lot B and all of Lots C, D and E, as shown on Plat of Property of Jas. J. Prince, Esq., dated July 1, 1883 and recorded in Plat Book 1, page 147, Office of Register of Deeds for Greenville County, S. C., in having the following water and bounds, to-wit:

BOUNDING at an iron pin at the Northwest corner of the intersection of Crescent Avenue and Capers Street and running thence along the North side of Crescent Avenue, S. 5-35 W. 23.7 feet to a stake, at corner of lot conveyed by J. J. Prince to Jas. J. Prince, as defined in Deed Book 190, page 281; thence with the Prince lot, N. 3-35 W. 261 feet to a stake in the joint rear line of Lots A and B; thence N. 3-35 W. 13.7 feet to stake in joint rear line of Lot A; thence N. 3-35 W. 100.6 feet to a stake on soth line of Crescent Avenue, same being corner of lot A; thence with same line N. 3-35 W. 13.7 feet to a stake in corner of lot conveyed by J. J. Prince to Frank L. Pitcher by deed recorded in Plat Book 1, page 147, Office of Register of Deeds for Greenville County, S. C., thereby dividing lot A into two parts, 15 m. 20.4 feet to a stake; thence N. 3-35 W. 141.4 feet to a stake rear from corner of lot C and D; thence with same lot C 17-18 m. 200.7 feet to a stake on soth line of Northwesterly joint front corner of lots A and B; thence N. 3-35 W. 13.7 feet to a stake in joint front corner of the first resection of lot A; thence N. 3-35 W. 13.7 feet to a stake with the west line of Capers Street, S. 5-35 W. 13.7 feet to a stake in line.
