All of that certain piece, parcel or lot of land situate, lying and being in Greenville Township, Greenville County, State of South Carolina, and being known and designated as Lot No. 9 on plat of property of Knox L. Haynsworth, Trustee, prepared by Dalton & Neves, Engineers, May, 1941, and recorded in the R. M. C. Office for Greenville County in Plat Book L, at page 177, and having, according to said plat, the following metes and bounds, to-wit:
