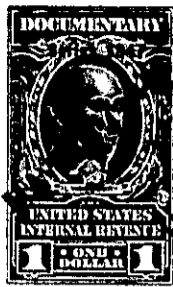

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents
do grant, bargain, sell and release unto the said Frank J. Belotte and Suzanne S. Belotte

all that piece, parcel or lot of land in Greenville Township, Greenville

County, State of South Carolina which is shown on Plat of property of Lucy L. Hindman located near Greenville, S. C. dated August 1937, made by W. S. Riddle, Surveyor. The property herein conveyed lies East of Bennett St, South of E Fairview Ave., and is shown on the above Plat as all of lot No. 5 and 10 ft. off of the western side of lot No. 6 and from the said Plat the following description is taken.

BEHAVING at a point on the South side of East Fairview Ave, which point is a joint front corner of lots Nos. 4 and 5, and running thence the joint line between these lots S. 22-57 .. 173 ft. to the joint rear corner of said lots; thence following to the rear line of lot No. 5 S. 67-03 E. 70 ft. to the joint rear corner of lots 5 and 6; thence continuing the same course along the rear line of lot No. 6, 10 ft. to a point in the rear line of lot No. 6; thence running a line through lot No. 6 parallel to and 10 ft. from the joint line between lots 5 and 6 S. 22-57 .. to a point in the front line of No. 6, and a distance of 173 ft. more or less; thence following the South side of East Fairview Ave, S. 67-03 .. 10 ft. to the joint front corner of lots 5 and 6; thence continuing the same course along the front line of lot No. 5 70 ft. to the beginning corner.
