

BEGINNING at an iron pin on Fairview Avenue, 458 feet from the southeast intersection of Laurens Road and Fairview Avenue, corner of Lot No. 10, and running thence along Fairview Avenue 50 feet, S. 31-47 W., to iron pin; corner of Lot 12; thence along line of lot 12, S. 58-40 E., 131.7 feet to iron pin, joint corner of lots 11, 12, 25 and 26; thence along rear line of lot 26, N. 31-20 E., 50 feet to iron pin, joint corner of lots 10, 11, 26 and 27; thence along line of lot 10, N. 58-40 W., 131.3 feet to the beginning corner, being the same lot as conveyed to Sara T. and Jay R. BEGINNING at an iron pin on Fairview Avenue, 508 feet from the southeast intersection of Laurens Road and Fairview Avenue, corner of lot 11, and running thence along Fairview Avenue 50 feet, S. 31-47 W., to iron pin, corner of Lot 13; thence along line of lot 13, S. 58-40 E. 132 feet to iron pin, joint corner of lots 12, 13, 24 and 25; thence along rear line of hot 25, N. 3120, E., 50 feet to iron pin, joint corner of lots 11, 12, 25 and 26; thence along line of lot 11, N. 58-40 W., 131.7 feet to the beginning corner, being the same lot as conveyed to Imogene C. and Ralph P.
