

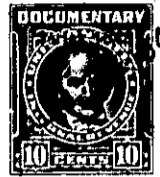
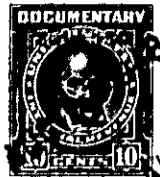

KNOW ALL MEN BY THESE PRESENTS, That I, C. A. Bouchillon.....

in the State aforesaid, in consideration of the sum of thirty-nine hundred and fifty (\$3950.00)  
dollars, and the assumption of the mortgage hereinbelow described..... Dollars  
to me..... in hand paid at and before the sealing of these presents  
by Harvey D. Long and Mary E. Long.....

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these  
presents do grant, bargain, sell and release unto the said Harvey D. Long and Mary E. Long and  
their heirs and assigns forever

all that piece, parcel or lot of land in Paris Mountain Township, Greenville

County, State of South Carolina, containing 5.13 acres, more or less, according to Survey  
and Plat by A. H. Dalton, dated July 1944, and being more particularly described as  
follows:

BEGINNING at a stake on the western side of Hunt's Bridge Road,  
corner of lands of J. K. Keller, and running thence with said Road  
S. 1-51 W. 70 feet to a stake where the western line of the White  
Horse Road intersects the western line of said Hunt's Bridge Road; thence  
with the White Horse Road S. 17-36 W. 332 feet to an iron pin; thence  
with property of James S. or Thelma E. Keller as follows: N. 83-0 W.
