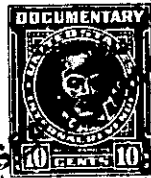
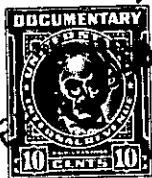

dollars (\$2540.00) and the assumption of the mortgage hereinbelow described
to me..... in hand paid at and before the sealing of these presents
by Hazel P. Callahan.....

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these
presents do grant, bargain, sell and release unto the said Hazel P. Callahan and her heirs and
assigns forever

all that piece, parcel or lot of land in Chick Springs Township, Greenville

County, State of South Carolina, beginning at the corner of Bennie Connor's lot and running
thence in a northerly direction along the Connor line two hundred and twenty feet (220),
more or less, to a pin; thence in an easterly direction one hundred and seventy feet
(170), more or less, to a twenty foot (20) drive; thence in a southerly direction along
said drive two hundred and thirty feet (230), more or less, to the Worley Road; thence
along the Worley Road one hundred forty seven and one-half feet (147½), more or less,
to the beginning corner.

ALSO, all that piece, parcel or lot of land in Chick Springs Township, Greenville
County, State of South Carolina, beginning at the corner of lot of Jeff Raines and
Lille Bell Raines, and running in an easterly direction one hundred and seventy feet
(170), more or less, to a twenty foot (20) drive; thence along said twenty foot (20)
drive in a northerly direction fifty feet (50), more or less, to a pin; thence in a
westerly direction one hundred and seventy six feet (176), more or less, to Connor's
line; thence with Connor's line fifty feet (50) to the beginning corner.
