Dougherty, her Heirs and Assigns forever,

All my interest in all those lots of land in Greenville Township, Greenville County, State of South Carolina, on the Eastern side of Buncombe Road (U. S. Highway No. 25), being shown as Lots Nos. 3, 4, 18 and 19 on Plat of property of W. M. Batson and Helen B. Dougherty, made by Dalton and Neves in July 1948, and recorded in Plat Book S at Page 105, and described as follows:

BEGINNING at a stake on the Eastern side of the Buncombe Road, at corner of Lot No. 2, and running thence with the line of Lots Nos. 2 and 20, N. 86-10 E. 411.5 feet to a stake on Cherrydale Drive; thence with the Western side of Cherrydale Drive, S. 25-55 E. 107.8 feet to a stake at corner of Lot No. 17; thence with the line of Lots Nos. 17 and 5, S. 86-10 W. 451.5 feet to a stake on Buncombe Road; thence with the Eastern side of said Road, N. 3-50 W. 100 feet to the beginning corner.
