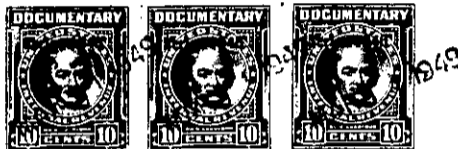
to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Henry T. Mills, Jr., his Heirs and Assigns forever,

All that certain piece, parcel or lot of land in Gantt Township, Greenville County, State of South Carolina, being known and designated as a portion of Lots Nos. 34, 35 and 36 as shown on a Plat prepared for Bruce and Berry, recorded in Plat Book "J" at Pages 52 and 53, and having, according to a more recent survey prepared by Piedmont Engineering Service, June 25, 1947, recorded in Plat Book "R" at Page 185, the following metes and bounds, to-wit:

BEGINNING at the joint corner of the tract hereinafter described and lands of Granger and Baker, and running thence with Granger's line, N. 20-54 E. 1153.2 feet to an iron pin in line of the Earle Property; thence with the line of said property, S. 77-31 E. 545.3 feet to an iron pin, corner of Earle and Davis; thence along line of the Davis property, S. 4-49 W. 1151.9 feet to an iron pin, joint corner of the Davis and Baker property; thence along the line of the Baker property, N. 77-35 W. 886.4 feet to the beginning corner.

Said premises being the same conveyed to the Grantor by W. O. Epps and Mary A. Epps by deed dated December 31, 1948, recorded in Book of Deeds 369 at Page 372.
