Know All Men by These Presents:

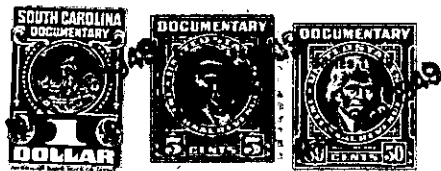
That I, L. T. Jones, in consideration of the sum of Four Hundred and No/100 - - - - - (\$400.00) - - DOLLARS,
