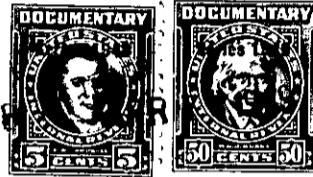
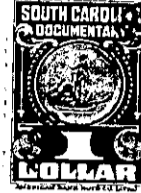

of South Carolina, lying and being situate on the Northwest side of Cammer Avenue within

the present limits of the City of Greenville, South Carolina, being known and designated as Lots # 14 and # 15, Augusta Road Hills, as shown on revised plat of said sub-division prepared by Dalton & Neves, ^{revised} in October 1941, as recorded in the R.M.C. Office, Greenville, South Carolina, in Plat Book "M" on Page 33, and having, according to said revised Plat, the following metes and bounds to wit:

BEGINNING at an iron pin on the Northwest side of Cammer Avenue at joint front corner of Lots # 13 and # 14; thence along the dividing line of said Lots N. 47-50 W. 177.4 feet to an iron pin at joint rear corner of Lots # 13 and # 14; thence along the rear line of Lots # 14 and # 15 S. 42-07 W. 130 feet to an iron pin at joint rear corner of Lots # 15 and # 16; thence along the dividing line of said Lots S. 47-50 E. 166.5 feet to an iron pin on the Northwest side of Cammer Avenue at joint front corner of Lots # 15 and # 16; thence along said Avenue N. 46-55 E. 130.2 feet to an iron pin at joint front corner of Lots # 13 and # 14, the point of beginning.

The herein named grantee is to pay the 1949 taxes on the above-described property.

The above-described property is subject to restrictions recorded in the R.M.C. Office, Greenville, South Carolina, in Volume 231 at Page 297, and said restrictions are hereby incorporated in this deed by reference.
