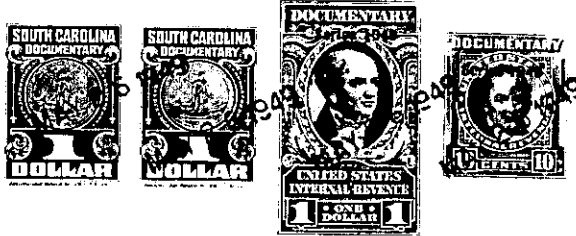
"All that lot of land in Greenville Township, Greenville County, State of South Carolina, on the Southern side of Douglass Drive, in the City of Greenville, being shown as Lot No. 36 on Plat of Country Club Estates, made by Dalton & Neves in October, 1926, recorded in Plat Book G at Pages 190 and 191, and described as follows:

"BEGINNING at a stake on the Southern side of Douglass Drive 450 feet West from Ridge Drive at corner of Lot No. 35, and running thence with the line of said lot, S. 23-22 E. 150 feet to a stake; thence S. 72-20 W. 50.3 feet to a stake at corner of Lot No. 37; thence with the line of said lot, N. 23-22 W. 143.3 feet to a stake on Douglass Drive; thence with the Southern side of Douglass Drive, N. 66-38 E. 50 feet to the beginning corner."

Being the same lot conveyed to the Grantor by T. A. Hale by deed dated June 12, 1947, recorded in Book of Deeds 314 at Page 20.
