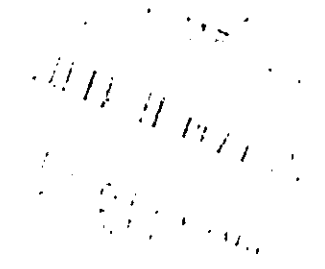

KNOW ALL MEN BY THESE PRESENTS, That I, Broadus L. Ballenger, Un-

to me in hand paid at and before the sealing of these presents

by G. Harrison Bridgeman and wife, Lecie C. Bridgeman

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said G. Harrison Bridgeman and wife, Lecie C. Bridgeman,

all that piece, parcel or lot of land in Glassy Mountain Township, Greenville County, State of South Carolina, more particularly described as follows: Being Lots No. 23 & 26 in "N" Section -

BEGINNING at an iron pin at the Southeasterly edge of Piedmont Drive said Drive being forty feet wide, and the Easterly corner of Lot No. 24 Section N, thence with the Southeasterly edge of Lot No. 24, Section N, in a southwesterly direction, South forty three degrees twenty eight minutes West, One Hundred Fifty-Five (155.0) feet to an iron pin, the Southerly corner of Lot No. 24, Section N, and the Easterly corner of Lot No. 25, Section N; thence, still in a Southwesterly direction with the Southeasterly edge of Lot No. 25, Section N, South forty three degrees sixteen minutes West, One Hundred Seventy and six-tenths (170.6) feet to an iron pin in the Northerly edge of said Piedmont Drive, the Southerly corner of Lot No. 25, Section N, thence following the curve of said Drive in a southeasterly direction, One hundred Twenty Five (125.0) feet to an iron pin the Westerly corner of Lot No. 27, Section N; thence in a Northeasterly direction with the Northwesterly edge of Lot No. 27, Section N, North forty degrees thirty three minutes East, one hundred seventy seven and one tenth (177.1) feet to an iron pin, the Northerly corner of Lot No. 27, Section N, and the Westerly corner of Lot No. 22, Section N; thence, still in a Northeasterly direction, with the Northwesterly edge of Lot No. 22, Section N, North forty degrees thirty three minutes East, One Hundred Forty Five (145.0) feet to an iron pin in the Southwesterly edge of Piedmont Drive, the Northerly corner of Lot No. 22, Section N, thence following the curve of said drive in a northwesterly direction, one Hundred Ten and two-tenths (110.2) feet to an iron pin at the beginning.

Reference is hereby made to a plat of said property, prepared by A. A. Merrick, Engineer, which is attached to this instrument and is hereby made a part of this description.
