

Township, Greenville

County, State of South Carolina, on Ackley Road and Maco Street, and being shown and designated as Lot Number one (No. 1) according to a plat of the property of Central Realty Corporation recorded in the R.M.C. Office for Greenville County in Plat Book "P" at page 7, and according to the said plat, having the following metes and bounds, to vit:

BECINNING at a point on Maco Street, southeastern corner of Maco Street and Ackley Road, and running thence N. 65-15 E. 82 feet along the southern side of Ackley Road, to point; thence 3. 36-05 E. 64 feet; thence S. 54-03 M. 80 feet along the nor thern line of Let No. 2 on said plat, to point on eastern side of Maco Street, thence M. 36-05 M. 78 feet along the eastern side of Maco Street, to the point of beginning.
