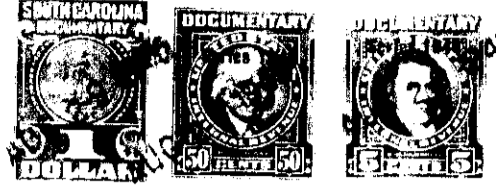

all that piece, parcel or lot of land in Glassy Mountain Township,

County, State of South Carolina, adjoining land of Fred Wofford and more fully described as follows: Beginning at an iron pin on north margin of road leading from Wofford Land to Tryon, N.C. and runs S. 72 W. 224 feet to a stone W. A. Ballew's corner on branch bank; thence with and up the branch N. 4 E. 122 feet to forks of branch, five calls as follows, viz: N. 80 W. 228 feet to center of bridge, N. 33 W. 155 feet, N. 57 W. 17 feet, passing over the center of falls, N. 52 W. 100 feet, N. 37 W. 92 feet to an iron pin on west bank of branch and in an old road; thence S. 78 W. 365 feet to stake; thence S. 67 E. 586 feet to the beginning, containing 4 acres, more or less.

ALSO: All that piece, parcel or lot of land in Glassy Mountain Township, Greenville County, State of South Carolina, bounded as follows: Beginning at a stone on west side of Wofford Creek an old established corner and runs S. 67 W. 48 feet to a point in center of Wofford road; thence with said road three calls as follows: S. 23-30 E. 291 1/2 feet, S. 30 W. 100 feet, S. 23 W. 286 1/2 feet to a point in center of bridge corner of a tract conveyed by J. J. Gentry Jr. to Fred Wofford, recorded in book 147 of Greenville County, S.C.; thence with line of said tract S. 60 W. 100 feet at confluence of a small branch and Wofford's creek; thence with said creek as follows: North 90 feet, N. 28 W. 80 feet, N. 28 W. 100 feet, N. 5 E. 96 feet, N. 41 E. 70 feet, N. 5 W. 85 feet, N. 28 W. 100 feet, N. 54 W. 100 feet, N. 35-W 127 feet, N. 23 W. 41 feet to the beginning, containing two acres, more or less.
