10. Those two certain lots on the Southern side of Tenth Street and the Eastern side of Hawkins Avenue, described upon said plat of Section 5 of Judson Mills village as Lots 42 and 43.

11. All that certain lot of land lying South of the intersection of Eleventh Street and Honour Streets, being a part of Lot No.90 as shown upon said plat of Section 5 of Judson Mills Village, but being particularly described as follows: Beginning at the intersection of the property line along the South side of Eleventh Street with the property line on the Southwest side of Honour Street, thence with Honour Street S 51-12 E 69.5 feet to lands of Judson Methodist Church, thence along the line of such Church property S 45-37 W 175 feet, thence N 78-22 W 16.9 feet to the corner of Lot No.89, thence with Lot No.89 N 1-55 W 160 feet to Eleventh Street, thence with Eleventh Street N 88-05 E 92.6 feet to the beginning corner.

12. All that certain parcel or tract of land containing 41 acres, more or less, lying on both sides of a branch and extending from the Anderson Road near Honour Street Westwardly to the P. & N. Railroad. Beginning at Anderson Road going Westwardly the property is bounded by a lot of Duke Power Company on the South and then by Duke Power Company Car Track location and Goodrich Street to a point 90 feet West of Fifth Avenue, thence Southwardly 210 feet and Eastwardly 90 feet to Fifth Avenue, thence Southwardly along Fifth Avenue to a point 75 feet South of Heatherly Avenue, thence Westwardly 90 feet, thence Southwardly to Wilburn Avenue, thence Westwardly along Wilburn Avenue to the right-of-way of P. & N. Railroad, thence Northwardly along the P. & N. right-of-way 1161 feet to property of Duke Power Company, thence with the Duke Power Company lot, according to the plat thereof, N 80-08 E 167.6 feet, and N 9-58 W 298.3 feet to a point on the West side of Piedmont Avenue, thence N 79-44 E 190 feet, thence N 10-16 W 137 feet, thence Eastwardly along the Southern and Southwestern limits of Sections 2, 3, 4 and 5 of Judson Mills Village, plats of each by Dalton and Neves, Surveyors, recorded in Plat Book K in the office of the R.M.C. for Greenville County, to a point the Southeast Corner of Lot No.89 as shown upon the plat of said Section 5, thence S 78-22 E 16.9 feet to a corner of the Methodist Church lot, thence S 51-12 E 175 feet to an iron pin on the Anderson Road. From within said boundaries, a small lot 50' x 100' at the corner of Third Avenue and an unnamed street one block South of Sixth Street has been conveyed to Boy Scouts of America.

13. The following numbered lots as shown upon a plat entitled "Map of Judson Mills No.2 Village" dated March, 1939 and recorded in said office in Plat Book K, at pages 1 and 2; Lots 2 and 15 of Block D, Lots 1, 2 and 3 of Block E; Lots 1, 13, 14, 15, 16, 17, 18 and 19 of Block H; and in addition to the numbered lots in Block E the land lying South of said Lots 1, 2 and 3 and North of the property
