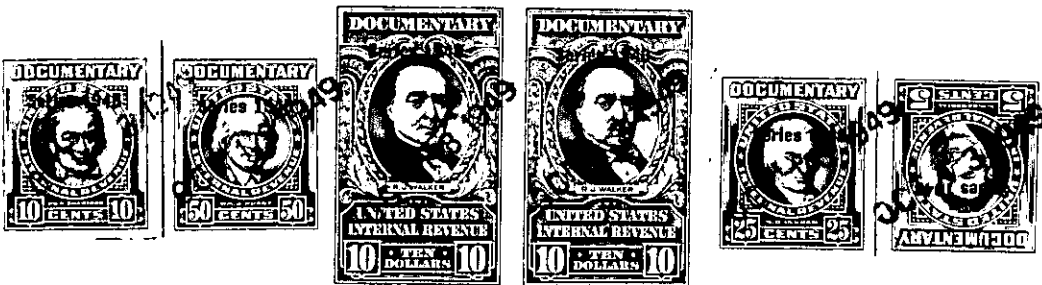
FRED W. GASSE AND RUTH A. GASSE

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FRED W. GASSE AND RUTH A. GASSE, Their Heirs and Assigns:

All that piece, parcel or lot of land with the improvements thereon situate, lying and being on the Southeastern side of Dukeland Drive, in the County of Greenville, State of South Carolina, and being known as Lots 35, 36, 37, 38, 39 and a part of Lot 40 of Dukeland Park as shown on a plat thereof prepared by Dalton & Neves, June, 1940, and recorded in the R. M. C. Office for Greenville County in Plat Book J, at pages 220 and 221, and having according to said plat the following metes and bounds, courses and distances:

BEGINNING at a point on the Southeastern side of Dukeland Drive, which point is 10 feet Southwest of an iron pin, the joint front corner of Lots 40 and 41, and running S. 54-18 W. along the Southeastern side of Dukeland Drive 290 feet to a point, the joint front corner of Lots 34 and 35; thence along the common line of Lots 34 and 35 S. 35-42 E. 156.1 feet to a point in the rear line of Lot 28; thence along the rear line of Lots 28 and 27 S. 81-32 E. 95.8 feet to an iron pin; thence along the rear line of Lot 26 N. 83-45 E. 35 feet to an iron pin; thence along the rear line of 2 unnumbered lots N. 83-35 E. 77.4 feet to a point; thence along property now or formerly of the Perry Estate N. 33-13 E. 146.4 feet to a point, the joint rear corner of Lots 40 and 41; thence in a Northwesterly direction through the Northeastern portion of Lot 40 235 feet, more or less, to the Southeastern side of Dukeland Drive, the point of beginning.

The above described property includes all of Lot 40, less a triangular portion thereof, said triangle fronting on Dukeland Drive 10 feet, heretofore conveyed to D. V. Turbeville by deed to be recorded.
