

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto barsaid Rachael M. Cockey and Preston O. Cockey, their heirs and asigns forever all that piece; parcel or lot offland in Greenville Township, county and state aforesaid about three miles from Greenville Courthouse, being known and designated as Lot Nos. 53 and 54 of Sunset Hills, according to a plat thereof, made by R. E. Dalton dated December, 1945, recorded in the R. M. C. Office for Greenville Courty, South Carolina, in Plat Book P, at Page 19, and according to said Plat, having the following metes and bounds, to-wit:

BEGINNING at an iron pin on Seminole Drive corner of Lot No. 55 and running thence along the line of Lot No. 55 S. 48-50 W. 175 feet to an iron pin; thence S. 41-10 E. 136.6 feet to an iron pin; thence N. 55-30 E. 176.15 feet to an iron pin on Seminole Drive; thence along said Drive N. 41-10 W. 156.6 feet to the beginning corner.
