McAlister, made by Pickell & Pickell, Engineers, dated October 16, 1948, and recorded in the R.M.C. Office for Greenville County in Plat Book S, Page 153, and

front corner of Lots 63 and 64, said pin being 300 feet in a Northerly direction from the Northeast intersection of Little Texas Road and Hill Top Drive, and running thence along the East side of Hill Top Drive N. 15-07 E. 100 feet to an iron pin at corner of Lot 65; thence along line of said Lot 65 S. 69-29 E. 228.4 feet to an iron pin; thence S. 40-16 W. 105.8 feet to an iron pin at rear corner of Lot 63; thence along line of said Lot 63 N. 69-29 W. 183.4 feet to the beginning corner.
