Office for Greenville County, Lot No. 44 fronts on Ashmore Street, and has a uniform width of 70 feet and a depth of 176 feet. Lot No. 47 adjoins No. 44 and fronts on Caldwell Street, and has a width of 70 feet and a depth of 173 feet.

This property is to be used only for residential purposes with desirable appurtenances thereto, for White people only, and specifically prchibited are trailer camps, tourist courts, clubs, dance halls and so-called "honkeytonks" or "juke-joints", and the sales of beer, wine and alcoholic liquors. No dwelling house shall be erected for a cost of less than \$3500, and the same must be placed at least 20 feet from the street on which it faces. These restrictions are for the benefit of the grantor and all owners of property in this subdivision, and any violation thereof shall entitle any owner of the same to injunctive relief. However, the rights of lien creditors shall not be impaired by violations of these restrictions.
