

KNOW ALL MEN BY THESE PRESENTS, That Bee Tree Vermiculite Mines, Inc.
a South Carolina Corporation

Tigerville in the State of South Carolina
for and in consideration of the sum of Seven Thousand and no/10.3 (\$7000.00Dollars,
to it in hand duly paid at and before the sealing and delivery of these presents by the grantee
hereinafter named (the receipt whereof is hereby acknowledged), has granted, bargained, sold and
released, and by these presents does grant, bargain, sell and release unto Zonolite Company,
a Corporation, its successors and assigns, forever:

All that piece, parcel or lot of land in Highland Township. Greenville County, State of South Carolina in School District 13B, and having the following metes and bounds, to-wit:

BEGINNING at a point in the property line of Tiger Baptist Church 140 feet Southwest of the joint corner of E. C. Stroud and Boyd McKinney in property of said Church line, and running thence N. 45 E. 140 feet to the joint corner of E. C. Stroud and Boyd McKinney in said Church line; thence S. $49\frac{1}{2}$ E. with the said McKinney line 167.3 feet to a point in road, joint corners of the lands of Boyd McAinney and W. S. Bradley; thence with the line of the property of W. S. Bradley, S. 27 E. 443 feet to a point in said Road; thence S. $45\frac{1}{2}$ W. 150 feet; thence in a straight line to the beginning corner, containing 2 acres, more or less, and bounded by lands of McKinney and Bradley on the East, by lands of E. C. Stroud on the South and west and lands of Tiger Baptist Church on the North.

ALSO, all that piece, parcel or lot of land in Highland Township, Greenville County, State of South Carolina, and being located one and one-half miles East of Tigerville and South of the Turalo Road, and having the following metes and bounds, to-wit:

BEG_NNING at a pin in the intersection of the Cld Tugalo and Cox Mills Roads; and running thence N. 63-40 E. 628 feet to a point in surface treated Road (Tugalo); thence N. 82-53 E. 283 feet to a point at the intersection with County Road; thence with said County Road, S. 16-20 W. 600 feet to a bend in Road; thence S. 32-30 W. 464 ; thence S. 76 W. 136 feet to a pin along line of dightower property; feet to a point in Cox Mills Road; thence N. 17-0 W. 420.4 feet to a bend in said Cox Mills Road; thence N. 30-30 W. 332 feet to the beginning point and containing 10.16 acres, more or less.
