

CHARTER  
BY THE SECRETARY OF STATE

WHEREAS, FRED A. FULLER, JR. AND FRED A FULLER  
both of Greenville, S. C.

did on the 3rd day of January, 1950, file with the Secretary of State a written Declaration,  
signed by themselves, setting forth:

FIRST: That their names and residences are as above given.

SECOND: That the name of the proposed corporation is FRED A FULLER APPLIANCES, INC.

THIRD: That the principal place of business is GREENVILLE, S. C.

FOURTH: That the general nature of the business which it is proposed to do is to engage in the appliances sales business and to handle household, kitchen and other appliances, equipment and accessories and to own or lease real estate independently or in connection with the operation of said business and to do all things necessary, proper or incident thereto, and to have and exercise all the general powers conferred upon business corporations under the general laws of the State of South Carolina.

FIFTH: That the amount of the capital stock is Forty Thousand (\$40,000.00) - - - - Dollars payable in cash or property.

SIXTH: That the number of shares into which the capital stock is divided is Four Hundred (400) of the par value of One Hundred (\$100.00) - - - - - Dollars.

SEVENTH: That, after due notice, a meeting of the subscribers was held on the 31st day of December, 1949 at which a majority of all stock in value being present in person or by proxy, the following were elected directors:

Fred A. Fuller, Jr. and Fred A. Fuller

EIGHTH: That subsequently there was elected as President, Fred A. Fuller, Jr. ; as Vice-President, Fred A. Fuller ; as Secretary, Fred A. Fuller ; as Treasurer, Fred A. Fuller, Jr.

NINTH: That all requirements of Article 2, Chapter 153, Code of Laws of South Carolina, 1942, and all amendments thereto have been duly and fully complied with, 50 per cent. of the aggregate amount of the capital stock having been subscribed by bona fide subscribers, 20 per cent. of the capital stock subscribed having been paid to the Treasurer, and three days' public notice of the intention to file this Declaration with the Secretary of State having been given in the Piedmont
