All that certain piece, parcel or lot of land with the buildings and improvements thereon, lying and being at the Southerly corner of the intersection of Alabama Avenue and Welcome Road near the City of Greenville being shown as lot #26 of Plat #4 of the property of Talmer Cordell recorded in the R.C.
