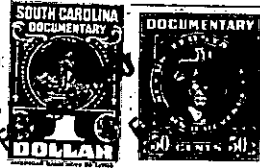

Said lot having a frontage of 50 feet on Palmetto Avenue and running back in parallel lines 125 feet to a 15-foot alley and being a portion of the property conveyed to us by M. W. Fore by deed dated September 30, 1947 and recorded in Deed Book 323, page 29, RMC Office for Greenville County.
