Know All Men by These Presents:

That I, Beulah Boggs
in consideration of the sum of One Dollar and Love and Affection in the State aforesaid, DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Gladys Brooks, my beloved sister, an undivided one-half interest in and to all that certain piece parcel or lot of land in Greenville Township, County of Greenville, State of South Carolina on the southeast side of West Hillcrest Drive, near the City of Greenville, being shown as lot no. 5 on plat of Druid Hills made by Dalton & Neves, Engineers, January, 1947, recorded in the RMC Office, Greenville County, S. C., in Plat Book "P", page 113, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeast side of West Hillcrest Drive at joint front corner of lots 4 and 5 and running thence with the line of lot 4, S. 41-54 E 206.8 feet to an iron pin; thence with the line of lot 22, N 62-27 E 63.6 feet to an iron pin; thence along the rear line of lots 20 and 21, N 10-12 W 182.9 feet to an iron pin; thence with the line of lot 6, N 74-20 W 115 feet to an iron pin on the southeast side of West Hillcrest Drive; thence with the southeast side of West Hillcrest Drive S 22-32 W 50 feet to an iron pin; thence continuing with the southeast side of West Hillcrest Drive S 36-16 W 50 feet to the beginning corner.

This property is subject to building restrictions applicable to Druid Hills which are recorded in Deed Book 309, page 15, RMC Office, Greenville County.
