Know All Men by These Presents:

That I, W. M. Raines in the State aforesaid, in consideration of the sum of Sixteen Hundred, Fifty and no/100---(\$1650.00)-----DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Dan H. McKinney and Nannie B. McKinney, their heirs and assigns, forever,

All that certain lot of land on the Southeast side of Super Highway #29, being shown as Lot #7 on plat of property of James M. Edwards, made by R. E. Dalton, Engineer, in April, 1948, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the Southeast side of Super Highway #29, at the joint front corner of lots #6 and #7, and running thence with line of lot #6, S. 47 E. 325 feet to an iron pin in line of other property of James M. Edwards; thence with line of said property, N. 43 E. 100 feet to iron pin, corner of lot #8; thence with said lot #8, N. 47 W. 325 feet to an iron pin on right-of-way of Highway #29; thence with said right-of-way, S. 43 W. 100 feet to the point of beginning.

This conveyance is made subject to the following restrictions, which are expressly made a part of the consideration thereof, and it is agreed that the same are for the mutual benefit of the Grantor, Grantee, and other persons owning lots shown on same Plat:

- (1) Said property shall be used for residential purposes for white people only.
(2) Said property, nor any part thereof, shall ever be used, sold, or otherwise disposed of, to persons of African descent.
(3) That no filling station, tourist camp, or public dance hall shall be constructed on said property.
(4) That no dwelling shall be erected upon said lots that costs less than \$10,000, (but this restriction shall not apply to servant's quarters erected on the rear of said lot), nor less than 100 feet from right-of-way of Highway #29.

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and their Heirs and Assigns forever.

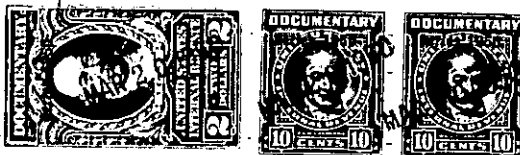
And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular, the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
