Know All Men by These Presents:

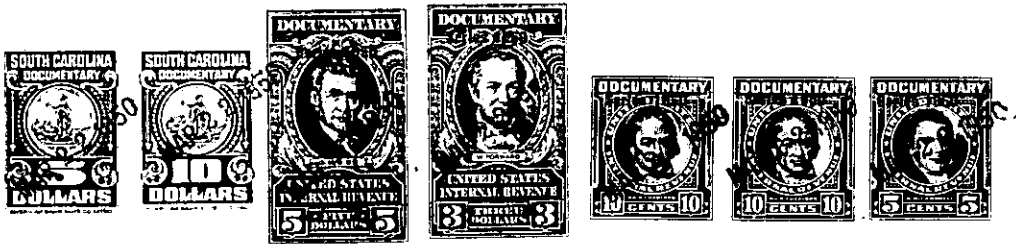

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Louis N. Shott, his Heirs and Assigns forever,

All that lot of land in Paris Mountain Township, Greenville County, State of South Carolina, on the Northern side of Long Forest Drive, being known and designated as Lot No. 18 on Plat of Nabors and Bridges, recorded in Plat Book C at Page 195, and having according to said Plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northern side of Long Forest Drive at joint corner of Lots Nos. 17 and 18, and running thence with joint line of said lots, N. 0-15 E. 359.9 feet to an iron pin at joint rear corner of said lots; thence due West 100 feet to an iron pin joint rear corner of Lots Nos. 18 and 19; thence with the joint line of said lots, S. 0-15 W. 359.4 feet to iron pin on Northern side of Long Forest Drive; thence with said Drive, S. 89-45 E. 100 feet to the beginning corner.
