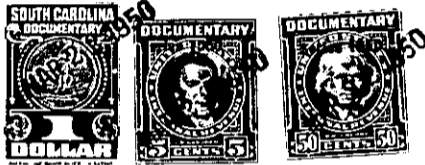
Know All Men by These Presents:

L. Howard and his heirs and assigns:

All of those parcels or lots of land situate and being in Oneal Township of Greenville County, South Carolina, lying about two miles northeast from the City of Greer, situate on the East side of a new street that leads from the Miller Bridge Road to the Old CC Camp Road, being all of lots Nos. 10 and 11 on a plat of property made for B.H. Burnett by J.Q. Bruce, Surveyor, dated February 6, 1950, and having the following courses and distances: BEGINNING on a stake on the eastern edge of said street, joint corner of lots Nos. 11 and 12 on said plat, and runs thence with the common line of said lots N. 88 E. 16 1/4 feet to a stake on line of lot No. 15; thence N. 11 W. 70 feet to a stake, joint corner of lots Nos. 9 and 19; thence W. 62.14 W. 207 feet to a stake on the eastern dege of said new street at intersection with the Old CC Camp Road; thence with the esatern edge of said street S. 11.00 E. 17 1/4 feet to the beginning corner.
