COLLIER, his heirs and assigns, forever:

All that certain piece, parcel or lot of land in the County of Greenville, South Carolina, near Woodside Cotton Mills, being known and designated as Lot "F" according to a plat of Woodside Mills, Greenville, South Carolina, prepared by Pickell & Pickell, Engineers, March 7, 1950, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at a point on the Northern side of East South Sixth Street, joint corner of Lots "E" and "F", which point is 375 feet West of the Northwestern intersection of Vance Street and East South Sixth Street and running thence with the joint line of said lots N. 15-49 E. 100 feet to a point; thence N. 74-11 W. 75 feet to a point, joint rear corner of Lots "F" and "G"; thence with the joint line of said Lots S. 15-49 W. 100 feet to a point in the Northern side of East South Sixth Street; thence with said street S. 74-11 E. 75 feet to the beginning point.
