HARRIS, his heirs and assigns, forever:

All that certain piece, parcel or lot of land in the County of Greenville, South Carolina, near Woodside Cotton Mills, being known and designated as Lot "C" according to a plat of Woodside Mills, Greenville, South Carolina, prepared by Pickell & Pickell, Engineers, March 7, 1950, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at a point in the Northern side of East South Sixth Street at the joint corner of Lots "B" and "C", which point is 100 feet West of the North-western intersection of Vance Street and East South Sixth Street, and running thence with the joint line of said lots N. 15-49 E. 100 feet; thence N. 74-11 W. 75 feet to a point, joint rear corner of Lots "C" and "D"; thence with the joint line of said lots S. 15-49 W. 100 feet to a point in the Northern side of East South Sixth Street; thence with the Northern side of said Street S. 74-11 E. 75 feet to the beginning point.

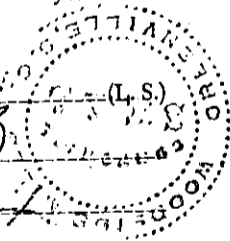

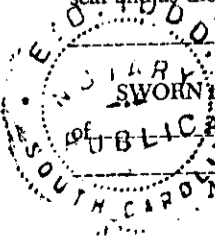
