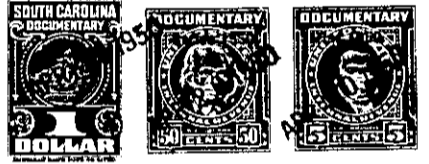
All that certain piece, parcel or lot of land, situate, lying and being on the Southeast side of Crosby Circle, in Gantt Township, in Greenville County, South Carolina, being shown as Lot 141, on Plat of Paramount Park, made by Piedmont Engineering Service, July 1949, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book "W", at page 57, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southeast side of Crosby Circle; at joint front corner of Lots 140 and 141, and running thence with the line of Lot 140, S 26-00 E 150 feet to an iron pin; thence S 64-00 W 70 feet to an iron pin; thence with the line of Lot 142, N 26-00 W 150 feet to an iron pin on the Southeast side of Crosby Circle; thence with the Southeast side of Crosby Circle, N 64-00 E 70 feet to the beginning corner.
