GAFFNEY, her heirs and assigns, forever:

All that certain piece, parcel or lot of land situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, on the Western side of Broughton Drive, in a Subdivision known as Croftstone Acres, being known and designated as Lot No. 8, Section G, of the aforementioned Subdivision, and being described according to a plat of Croftstone Acres prepared by C. B. Dawsey, dated August, 1946, and recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book S, at Pages 78 and 79. The property herein conveyed has according to said plat the following metes and bounds, courses and distances, to-wit:-

BEGINNING at a point on the Western side of Broughton Drive at the joint front corner of Lots Nos. 7 and 8 of Section G, and running thence along the common line of said Lots in a Northwesterly direction 234 feet to a point, the joint corner of Lots Nos. 7, 8, 21 and 22, Section G; thence along the common line of Lots Nos. 8 and 21, Section G, in a Northwesterly direction 75 feet to a point, the joint corner of Lots 8, 9, 20 and 21, Section G; thence along the common line of Lots Nos. 8 and 9, Section G, in a Southeasterly direction 258.5 feet to a point on the Western side of Broughton Drive; thence along the Western side of Broughton Drive in a Southwesterly direction 90 feet to the beginning corner.
