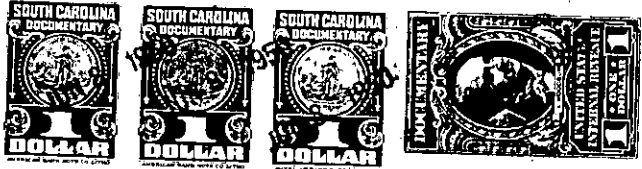

Know All Men by These Presents:

That I, James E. Renwick in the State aforesaid, in consideration of the sum of Eleven Hundred Ninety-Three and No/100 (\$1193.00) - - - DOLLARS, and assumption of mortgage set out below

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Roy C. Martin and Jane A. Martin, their heirs and assigns forever:

All that lot of land in Greenville Township, Greenville County, State of South Carolina, being known and designated as lot No. 22 on the Southern side of Darlington Avenue, between Berkley Avenue and Ethelridge Drive, and being more particularly described, according to Plat of Property of Ethel Y. Perry Estate, recorded in Plat Book Q at Page 24, as follows:

BEGINNING at an iron pin on the Southern side of Darlington Avenue, joint front corner of lots Nos. 22 and 23, which pin is 330 feet East of the Southeast intersection of Darlington Avenue and Berkley Avenue, and running thence with the joint line of said lots, S. 47-0 E. 131 feet to an iron pin; thence along the rear line of lot No. 7, N. 43-0 E. 60 feet to an iron pin, joint rear corner of lots Nos. 21 and 22; thence with the joint line of said lots, N. 47-0 E. 131 feet to an iron pin on Darlington Avenue; thence with said Avenue, S. 43-0 W. 60 feet to the point of beginning.

Said premises being the same conveyed to the grantor by J. A. Cannon, Jr. by deed recorded in Volume 385 at Page 242.

As a part of the consideration for this deed the grantees assume and agree to pay a balance of \$6307.00 due on a mortgage executed by the grantor to Fidelity Federal Savings & Loan Association in the original sum of \$6500.00 recorded in Book of Mortgages 431 at Page 60.

Grantees are to pay 1950 taxes.
