in consideration of the sum of Eighteen Hundred and No/100 (\$1800.00)----- DOLLARS,

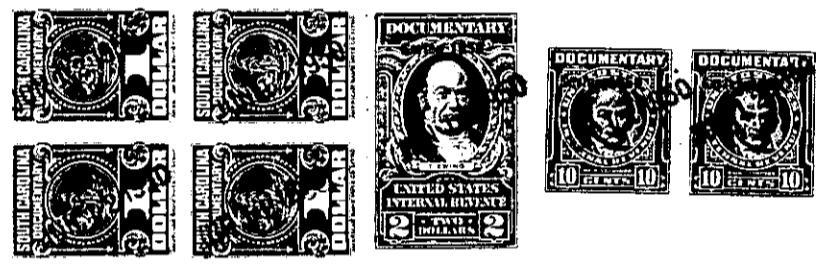
