do grant, bargain, sell and release unto the said... J. Kenneth Davis, his heirs and.....
assigns, forever; reserving, however, unto myself the right to use
and enjoy the premises herein described and to receive the income
therefrom for and during the term of my natural life.

All that certain piece, parcel or lot of land situate, lying
and being on Paris Mountain, in Paris Mountain Township, Greenville
County, South Carolina, Northeast of the Alta Mont Road, in the Sir-
rine Hill Section and being shown as Davis Hill, on Plat made by
Pickell & Pickell, Engineers, May 20, 1946, and having, according to
said plat, the following metes and bounds, to-wit:

N. 44-45 E. 80 feet to an iron pin; thence N. 35-00 E. 75 feet to
an iron pin; thence N. 18-00 E. 96 feet to an iron pin; thence N. 30-
45 W. 100 feet to an iron pin; thence N. 42-05 W. 187.5 feet to an
iron pin; thence S. 87-30 W. 115 feet to an iron pin; thence S. 61-
15 W. 180 feet to an iron pin; thence S. 52-45 W. 265 feet to an
iron pin; thence S. 44-00 W. 83 feet to an iron pin; thence S. 9-25
W. 62.5 feet to an iron pin; thence S. 1-15 E. 80 feet to an iron
pin; thence S. 6-00 E. 105 feet to an iron pin; thence S. 27-30 E.
124.5 feet to an iron pin; thence S. 57-25 E. 204.5 feet to the be-
ginning at the fork of said road and containing according to plat
above mentioned 7.06 acres, more or less.
