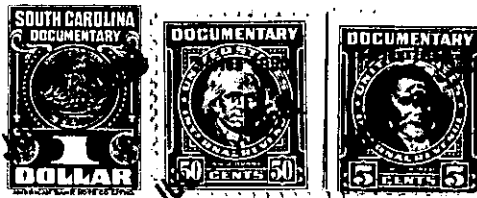

M. C. Office for Greenville County, S. C., in plat Book S, page 77.
