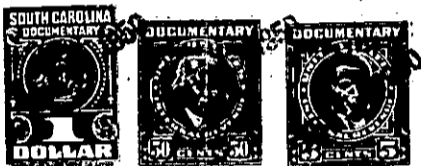
That I, Annie T. Henderson, in consideration of the sum of Five Hundred (\$500.00) in the State aforesaid, DOLLARS,
