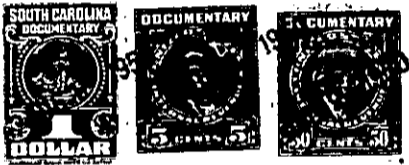

P. Asay, Jr., and T. G. Crymes, Jr., their heirs and assigns, all that piece, parcel or lot of land in Greenville Township, County of Greenville, State of South Carolina, lying and being situate on the Northern side of Potomac Avenue, within the limits of the City of Greenville, South Carolina, being known and designated as Lot #187, Pleasant Valley, according to plat of said subdivision prepared by Dalton & Neves in April, 1946, including additions to said Plat through February, 1950, as recorded in the R.M.C. 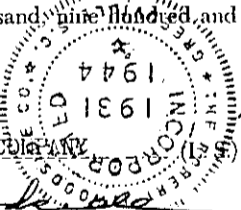
