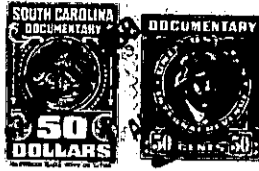

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), has (have) granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said F. L. Ashmore, C. E. Cheatham, P. R. Chiles, W. E. Gallman, W. J. Greer, M. M. Hewell, C. J. Lupo, J. L. Mahaffey and F. W. Mahon, as Trustees of Saint Paul Methodist Church of Greenville, South Carolina

All that certain piece, parcel, lot or tract of land lying, situate and being on the southwest side of Vardry Street, in the City of Greenville, State and County aforesaid, and having the following metes and bounds:

BEGINNING at a point at the intersection of Vardry Street and Anderson Street and running thence in a westerly direction with Vardry Street 147.7 feet, more or less, to line of property now or formerly owned by Elizabeth Williams Cox; thence with said Cox line in a southerly direction 204 feet, more or less, to line of Mills Steels; thence in an easternly direction with said Steele line 90 feet, more or less, to Anderson Street; thence in a northernly direction along the west side of Anderson Street 202 feet to the point of beginning, together with all right, title and interest in and to an alleyway across the property as reserved in deed of Florence E. Smith to Elizabeth Williams Cox March 31, 1919, recorded in the office of Register of Mesne Conveyance in Volume 34, Page 531.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
