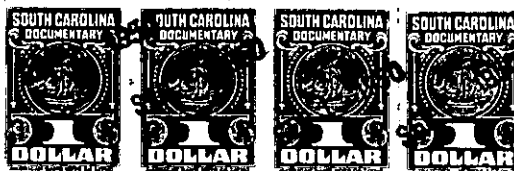

That J. M. Black in the State aforesaid, in consideration of the sum of Eighteen Hundred and No/100 (\$1800.00) - - - - - DOLLARS,

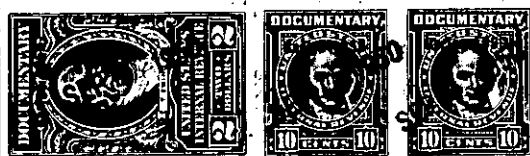

Williams, his heirs and assigns, forever:

All that certain piece, parcel or tract of land situate, lying and being on the North side of Hillendale Circle near the City of Greenville in Greenville County, S. C., being shown as Lot 16 on Plat of Property of J. M. Black made by Dalton & Neves, Engineers, December 1947, revised June 1949, recorded in the R.M.C. Office for Greenville County, S. C. in Plat Book "S", page 59 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the North side of Hillendale Circle at joint front corner of Lots 6 and 16 and running thence with the line of Lot 6 N. 0-30 W. 454.8 feet to an iron pin; thence N. 71-47 W. 356.7 feet to an iron pin at joint rear corner of Lots 15 and 16; thence with the line of Lot 15 S. 16-24 E. 589 feet to an iron pin on the North side of Hillendale Circle; thence with the North side of Hillendale Circle N. 89-10 E. 177 feet to the beginning corner and containing 3 acres more or less.
