

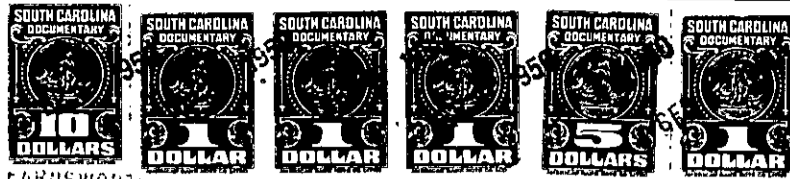

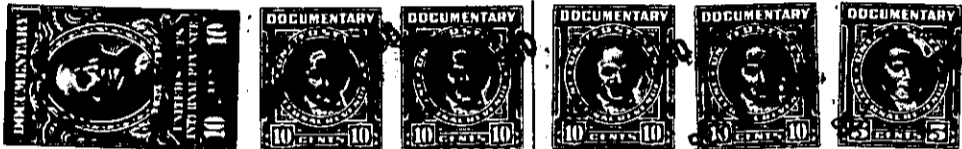

All that certain piece, parcel or lot of land with the improvements thereon, situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, on the Northeast side of Waccamaw Circle, being shown as all of Lot 98 on Plat No. 2 of "Sunset Hills", prepared by R. E. Dalton, Engineer, in October, 1949, which plat is recorded in Plat Book "P", at page 18, R. M. C. Office for Greenville County, S. C., and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northeast side of Waccamaw Circle, joint front corner of Lots 99 and 98, thence along line of Lot 99, N. 48-50 E. 175 feet to an iron pin; thence N. 41-10 W. 75 feet to an iron pin, rear corner of Lot 97; thence along line of Lot 97, S. 49-50 W. 175 feet to an iron pin on the Northeast side of Waccamaw Circle; thence with said street as the line, S. 41-10 E. 75 feet to point of beginning.

This conveyance is subject to the restrictive covenants set forth in instrument executed by Noland Meyers, dated March 6, 1949, recorded in Deed Book 288, at page 204, R. M. C. Office for Greenville County, S. C.
